The Staff Selection Commission declared the result of the Paper-I of Written Examination for Upper Division Grade Limited Departmental Competitive Examination, 2016 on 11.01.2017 for making additions to the Select List of Upper Division Grade of the following Services/ Cadres:-

- (v) Alphabetical order of the first names of candidates.

The list of the candidates is subject to fulfilling all the eligibility conditions prescribed in the Notice of the said examination and also subject to, among other things, thorough verification of their identity with reference to their photographs, signatures, handwritings, etc. on the Application Forms, Admission Certificates etc.
