Junior Engineers(Civil, Mechanical, Electrical, Quantity Surveying and Contract) Examination, 2013 – Declaration of result of Written Examination to call candidates for interview.

The Staff Selection Commission had conducted **Junior Engineers(Civil, Mechanical, Electrical, Quantity Surveying and Contract) Examination, 2013** on all India basis for recruitment to the posts of Junior Engineer(Civil), Junior Engineers(Electrical) in Central Public Works Departments(CPWD) and Department of Posts, Junior Engineer(Civil), Junior Engineer(Electrical & Mechanical), Junior Engineer(Quantity Surveying and Contract) in Military Engineering Service(MES), Junior Engineer(Civil & Mechanical) in Central Water Commission(CWC) and Farakka Barrage on 09.06.2013.

2. Result of Paper-I for evaluation of Paper-II of the aforesaid examination was declared on 05.11.2013 on the basis of which a total number of 4809 candidates qualified for evaluation of Paper-II of Civil Engineering whereas 1980 candidates qualified for evaluation of Paper-II of Electrical / Mechanical Engineering.

3. Based upon the cut-off marks fixed by Commission in Paper-II, following are the category-wise details of the candidates who are eligible for being called for Interview :-

7. The list is **PROVISIONAL**. The candidates whose roll nos. figure in the list would be called for Interview/personality test subject to their fulfilling all the eligibility conditions/requirements as prescribed for post in the Notice of Examination and also subject to thorough verifications of their identity with reference to their photographs, signatures, handwritings, etc., on the application forms, admission certificates, etc. If on verification of the application form, it is found that any candidate does not fulfill, any of the eligibility conditions, he/she will not be called for the Interview/personality test.

8. The category status in respect of candidates belonging to reserved categories has been indicated along with their roll numbers. If any candidate finds a mismatch between his/her name, roll number and category, he/she may bring it to the notice of the respective Regional Office of the Commission immediately.

9. The Interview will commence from 30th January, 2014. The Interview schedule will be available on concerned Regional Office's website by 15th January, 2014. Qualified eligible candidates who do not receive call letters for the Interview by **25th** January, 2014, should contact the concerned Regional Offices of the Commission immediately.
