120 (One Hundred and Twenty) candidates were shortlisted for next stage of scrutiny on the basis of the results of Computer Based Examination of Phase XII/2024/Selection Posts as per Result Write-up of the said Examination issued by Commission vide F.No.HQ-RHQ015/1/2024-RHQ dated 30.08.2024. Out of the same, 84 candidates had uploaded soft copy of documents through web portal within the stipulated date i.e 24.09.2024 (23:00 hrs). The soft copies of documents submitted by the candidates along with Online Application received from the SSC HQrs in respect of above post category were forwarded to the User Department for scrutinizing at their end. On scrutiny of documents by the User Department, it was found that none of the candidates fulfilled the eligibility conditions with regard to Educational Qualification as per Recruitment Rules prescribed for the captioned post. The tentative list of accepted and rejected candidate(s) for the said Post Number was published on the website of SSC (SR) on 06.01.2025. The rejected candidates were given 10 days time to represent their grievance(s) to SSC (SR) through email. No representation was received from the tentatively rejected candidates for the above captioned post within the stipulated date i.e 16.01.2025. Subsequently, List of finally rejected and provisionally accepted candidate(s) was uploaded in SSC (SR) website on 21.02.2025. Hence, NO candidate could be shortlisted for the post of Master Grade-I in HQANC/HQENC, Integrated Head Quarters, Ministry of Defence (Navy), Naval Dockyard, Vishakhapatnam advertised vide Post Number No. SR13124 as **NONE of the candidates** shortlisted for next stage of scrutiny on the basis of the results of Computer Based Examination for the said post was found eligible during scrutiny for the Document Verification Stage.
