RECRUITMENT TO THE POST OF ASSISTANT STORE KEEPER IN CENTRAL GROUND WATER BOARD, MINISTRY OF JAL SHAKTI, DEPARTMENT OF WATER RESOURCES, RIVER DEVELOPMENT & GANGA REJUVENATION, FARIDABAD

EQ: : (i) 12th pass from a recognized Board or equivalent possessing knowledge of Hindi (candidates who can speak Hindi to the extent of communicating verbally to others) and (ii) three years experience of maintaining stores accounts from Central Government or State Government or Public Sector Undertakings or Private Sector Company registered under the Companies Act.

60 (Sixty) candidates were declared qualified in Computer Based Examination for next stage of scrutiny. 29 (Twenty Nine) candidates submitted hard copy of application and supporting documents. On scrutiny, it was found that only two candidates declared qualified in CBE fulfil Educational Qualification as per Recruitment Rules prescribed for the captioned post. Meanwhile, CGWB vide Letter No. 6/03/2019-Admin-Engg.Est-6084 dated 20.09.2022 and e-mail dated 10.10.2022 withdrew two vacancies (SC-1 and OBC -1) out of 3 vacancies (UR-1, OBC-1 and SC-1) requisitioned for the post of Assistant Store Keeper. Hence, only one vacancy under UR category was available for filling up. Cancellation Notice dated 07.02.2023 of partial withdrawal of vacancies i.e SC-1 and OBC-1 was uploaded on SR website. Hence, in pursuance of Para 17.22 of the Notice of Advertisement No. Phase-IX/2021/Selection Posts, Additional list of 20 candidates were shortlisted by the Commission for next stage of scrutiny for Post Category No. SR11821 as per Result Write-up issued vide F.No. 15/1/2021-RHQ dated 16.06.2023. Out of 20 candidates shortlisted for next stage of scrutiny in Additional Result-4 for the said Post Category, 07 (Seven) candidates submitted hard copy of application and supporting documents. On scrutiny of the documents submitted by them, it was found that only one candidate fulfil the eligibility with regard to Educational Qualification as prescribed in the Recruitment Rules. Considering the eligibility of candidates as detailed above, 3 (Three) candidates were shortlisted for D.V. However, all the 3 (Three) candidates were 'Absent' for D.V held on 09.10.2023 at SSC (SR), Chennai. Hence, **NO** candidate could be shortlisted for the post of Assistant Store Keeper in Central Ground Water Board, Faridabad advertised vide Post Category No. SR11821.
