RESULT OF SELECTION POST**

RECRUITMENT TO THE POST OF MEDICAL ATTENDANT IN CENTRAL GOVERNMENT HEALTH SCHEME, MINISTRY OF HEALTH AND FAMILY WELFARE, CHENNAI

320 (Three Hundred and Twenty) candidates were declared qualified for the post of Medical Attendant(Post Category No. SR10721) for next stage of scrutiny on the basis of results of Computer Based Examination of Phase IX/2021/Selection Posts. 184 (One Hundred and Eighty Four) candidates submitted hard copy of application and supporting documents. On scrutiny it was found that 38 (Thirty Eight) candidates declared qualified in CBE were found to fulfill educational qualification as per the Recruitment Rules prescribed for the captioned post.

2. In pursuance of Para 17.22 of the Notice of Advertisement No. Phase-IX/2021/Selection Posts, subsequently, 232 (Two Hundred and Thirty Two) candidates were declared qualified in Additional Result – 1 of Computer Based Examination for next stage of scrutiny by the Commission vide F.No.15/1/2021– RHQ dated 08.12.2022. 104 (One Hundred and Four) candidates declared qualified in Additional Result – 1 submitted hard copy of application and supporting documents. On scrutiny of the documents submitted by them, it was found that 24 (Twenty Four) candidates declared qualified in Additional Result – 1 were found to fulfil educational qualification as per the Recruitment Rules prescribed for the captioned post.

3. Hence, Document Verification in respect of 62 candidates including 3 (Three) candidates under 'ST' category was conducted on 22.02.2023 & 23.02.2023. However, only one candidate under 'ST' category was present for Document Verification and his candidature was cancelled and debarred due to suspected case of impersonation.

4. Hence, in pursuance of Para 17.22, 20 (Twenty) candidates under 'ST' category were declared qualified in Additional Result – 8 of Computer Based Examination for next stage of scrutiny by the Commission vide F.No.15/1/2021– RHQ dated 03.11.2023. 7 (Seven) candidates declared qualified in Additional Result – 8 submitted hard copy of application and supporting documents. On scrutiny of the documents submitted by them, it was found that **none** of the candidates were found fulfilling eligibility conditions with regard to Educational Qualification as prescribed in the Recruitment Rules for the captioned post. Hence, one vacancy under 'ST' category for the captioned post could **not** be filled up due to non-availability of eligible candidates under ST category for the captioned post.

5. In the view of above, the result in respect of 20 candidates in Select List [(UR-12, EWS-4, SC-4) including 01 VH] against 21 vacancies [(UR-12, SC-4, ST-1 and EWS-4)including 01 VH] uploaded in website of SSC(SR) on 05.06.2023 **is final and will remain unchanged.**
