20 (Twenty) candidates were declared qualified in Computer Based Examination and shortlisted for next stage of scrutiny. 07 (Eleven) candidates submitted hard copy of application and supporting documents. On scrutiny, it was found that None of the candidates declared qualified in CBE fulfilled the eligibility with regard to Educational Qualification as per Recruitment Rules prescribed for the captioned post. Hence, in pursuance of Para 18.22 of the Notice of Advertisement No. Phase-X/2022/Selection Posts, 20 candidates were declared qualified in Additional Result-2 of CBE of the captioned Recruitment and shortlisted for next stage of scrutiny as per Result Write-up issued vide F.No. 15/1/2022-RHQ dated 29.05.2023. Out of 20 candidates shortlisted for next stage of scrutiny in Additional Result-2 for the said Post Category, 5 (Five) candidates submitted hard copy of application and supporting documents. On scrutiny of the documents submitted by them, it was found that none of the candidates fulfilled the eligibility with regard to Educational Qualification as prescribed in the Recruitment Rules. Hence, **NO** candidate could be shortlisted for the post of Instructor (Stenography) in National Career Service Centre for SC/ST, Chennai advertised vide Post Category No. SR10122.
