RECRUITMENT TO THE POST OF PHARMACIST-CUM-CLERK (UNANI) IN CENTRAL GOVERNMENT HEALTH SCHEME, MINISTRY OF HEALTH AND FAMILY WELFARE, HYDERABAD

Out of 20 candidates who were declared provisionally qualified for next stage of scrutiny on the basis of Results of Computer Based Examination for Higher Secondary Level Posts of Advertisement No. Phase-X/2022/Selection Posts held on 01.08.2022 and 05.08.2022, 08 candidates submitted hard copy of application alongwith copies of certificates in support of their claim for Age and EQ (including experience) for the said post. On scrutiny of the documents submitted by them, it was found that None of the candidates were found to be possessing the requisite EQ as mentioned in the Recruitment Rules for the post of Pharmacist-Cum-Clerk (Unani) in Central Government Health Scheme, Ministry of Health and Family Welfare, Hyderabad advertised vide Post Category No. SR12322. Hence, **NO** candidate could be shortlisted for Document Verification. Hence, in pursuance of Para 18.22 of the Notice of Advertisement No. Phase-X/2022/Selection Posts, Additional Result-2 for the post category No.12322 as per Result Write-up issued vide F.No.15/1/2022-RHQ dated 29.05.2023 was declared by the commission. 20 (Twenty) candidates were shortlisted for next stage of scrutiny on the basis of Additional Result-2 for the captioned post. Out of 20 candidates shortlisted for next stage of scrutiny in Additional Result-2 for the said Post Category, 05 (Five) candidates submitted hard copy of application and supporting documents. On scrutiny of the documents submitted by them, it was found that None of the candidates were found eligible in scrutiny of documents and they did not possess the requisite educational qualification as per the Recruitment Rules prescribed for the captioned post. Hence, **NO** candidate could be shortlisted for Document Verification and selected for the post of Pharmacist-Cum-Clerk (Unani) in Central Government Health Scheme, Hyderabad advertised vide Post Category No. SR12322.
