Transcription: 50 minutes on Computer.**

20 (Twenty) candidates were declared qualified in Computer Based Examination for next stage of scrutiny. 9 (Nine) candidates submitted hard copy of application and supporting documents. On scrutiny it was found that none of the candidates declared qualified in CBE were found to fulfil educational qualification as per the Recruitment Rules prescribed for the captioned post. Hence, in pursuance of Para 17.22 of the Notice of Advertisement No. Phase-IX/2021/Selection Posts, Additional Result was sought from HQRs. Subsequently, 20 (Twenty) candidates were declared qualified in Additional Result – 1 of Computer Based Examination by the Commission vide F.No . 15/1/2021 – RHQ dated 08.12.2022 for next stage of scrutiny. 10 (Ten) candidates declared qualified in Additional Result – 1 submitted hard copy of application and supporting documents. On scrutiny it was found that none of the candidates declared qualified in Additional Result – 1 also were found to fulfil educational qualification as per the Recruitment Rules prescribed for the captioned post. In view of above, NO candidate was shortlisted for Document Verification on the basis of Additional Result – 1 also and as such there is no candidate for preparing Select List/Reserve List. Hence one (1) UR vacancy for the post of Instructor (Stenography) in National Career Service Centre for SC/ST, Ministry of Labour & Employment, Directorate General of Employment, Hyderabad advertised vide Post Category No. SR11521 will remain unfilled.
